ENDORSEMENT

- 1. The plaintiffs have entered into a national settlement in these actions with the defendants, Holy Stone Enterprise Co., Ltd.; Vishay Polytech Co., Ltd. f/ka Holystone Polytech Co., Ltd; Milestone Global Technology, Inc. d/b/a Holystone International; and Holy Stone Holdings Co., Ltd.. They move to certify the actions for settlement purposes only and for approval of the proposed notices to class and plan of dissemination.
- 2. I recently granted the same relief in respect of a proposed settlement with the ELNA defendants.
- 3. The draft orders provided by plaintiffs' counsel are substantially the same as for the ELNA defendants save that they propose to amend the notices to the class(es) to inform class members of the two proposed settlements at the same time. The plan of dissemination for the notice to class is the same for both.
- 4. The parties propose that the settlement approval motion be heard at the same time as the approval motion for the ELNA settlement March 21, 2022 at 10 a.m.. That approach makes sense and is an efficient use of court resources.
- 5. I need not repeat the analysis for certification for settlement purposes for either action, having done so more than once in each action. I am satisfied on the material filed that the criteria for certification is met on the relaxed standard applicable to settlements.
- 6. I discussed with counsel a small revision to the proposed class definition in draft order in Allott v. AVX Corporation et al. Counsel will provide me with a revised draft order for my signature.

- 7. The proposed notices to the class(es) covering both the ELNA and Holystone settlements are approved. They will be in English and French. The plan of dissemination is likewise approved.
- 8. The motion to approve the settlements in both actions, and the motions for approval of class counsel fees in the Cygnus Electronics Corporation and Sean Allott v. Panasonic Corporation action will be heard Monday, March 21, 2022 at 10 a.m..
