 definitions set out in the Settlement Agreement apply to and are incorporated into this
 Order.
- THIS COURT ORDERS that the retainer agreements entered into with the representative plaintiffs Cygnus Electronics Corporation and Sean Allott are hereby approved pursuant to section 32(2) of the Class Proceedings Act, 1992.
- 3. THIS COURT ORDERS that the request of class counsel for payment of contingent legal fees of \$725,000.00 plus applicable taxes, and partial reimbursement of their disbursements, in the amount of \$225,000.00 plus applicable taxes, is approved.
- THIS COURT ORDERS that Class Counsel's legal fees, disbursements, and applicable taxes shall be paid from the Settlement Amount.
- 5. THIS COURT ORDERS that the Orders set out in paragraphs 3 and 4 above are contingent on parallel or equivalent Orders being made by the Supreme Court of British Columbia in the BC Action and by the Superior Court of Québec in the Québec Action.
